## Package A: Ages 3 – 6, 2 hours

**Maximum no. kids:** 12

### **Activities:**

- 1 five-minute pony ride per child
- Kids Obstacle Course
- Lunch / Snack Break (please see rules)
- Art Project
- Happy Birthday song and cake



**Price:** \$500 for up to 8 kids; additional kids are \$25 each, up to the 12-child limit.  
Adult participants do not cost extra and are not included in guest count.

### What you provide:

- 🐾 One balloon bouquet and one banner for the front of the BCEC
- 🐾 Tablecloths, cups, plates, napkins and utensils
- 🐾 Snacks and cake – *please note that the BCEC is a nut-free facility*

### What we provide:

- 🐾 Two 6’ banquet tables and 12 chairs
- 🐾 Up to two 6’ or 8’ banquet tables for food and dessert displays
- 🐾 Up to two 6’ or 8’ banquet tables for art activities
- 🐾 Up to two pop-up tents, as needed
- 🐾 Up to two ponies and three attendants, depending on party size

# **FAQ: Birthday Camp Policies, Rules, and Restrictions**

## **What spaces in the BCEC are open to the Birthday Camp?**

For the safety of our guests, boarders, and students, Birthday Camp access is limited to the party area: the BCRA arena, the Hillside arena, the round pen, the Courtyard, and the front entrance.





## **When is the BCEC available for Birthday Camps?**

The BCEC space and BCRA horses and ponies are currently available on weekend afternoons. This availability is subject to change as weather, Riding Academy, and COVID-19 conditions change. Please check with a BCRA or BCA staff member for the most current availability.

## **Who can book Birthday Camps?**

Right now, Birthday Camps are only available to Bell Canyon residents, current Bell Canyon Riding Academy students, and current BCEC boarders.

## **How is the BCRA handling COVID-19 safety?**

-  The Bell Canyon Riding Academy's priority during the continued COVID-19 pandemic is the safety of its attendees, students, parents, staff, and horses. To ensure a safe environment, masks must be worn when attendees, students, parents, staff, and/or volunteers are within a distance of 6' from each other. An exception may be made during activities that require eating or drinking.
-  Any attendee, renter, student, parent, staff, or volunteer displaying potential COVID-19 symptoms or having a positive COVID-19 test within 14 days of a scheduled event date may not enter the facilities or participate in in-person BCRA activities until they have been symptom-free for 14 days or have received 2 negative COVID-19 tests, taken consecutively and within three days of each other. Any attendee, renter, student, parent, staff, or volunteer who has anyone in their household, work, or school test positive for COVID-19 or display COVID-19 symptoms within 14 days of the scheduled event date may not enter the facilities or participate in in-person BCRA activities until the positive person or persons have been symptom-free for 14 days or have received 2 negative COVID-19 tests, taken consecutively and within three days of each other.
-  It is the responsibility of each renter, student, parent, staff, and volunteer to immediately inform the BCA, BCEC, and BCRA of any anticipated absence or needed reschedule due to COVID-19.
-  It is the responsibility of each renter, student, parent, staff, and volunteer to immediately inform the BCA, BCEC, and BCRA if they or anyone in their household, work, or school test positive for COVID-19 or display COVID-19 symptoms within 14 days of the event.
